### **APPROVAL TO REAFFIRM THE EASEMENT FOR 1 WEST MAIN STREET**

Walter made a motion, seconded by Sengle to acknowledge that the pipe from the parking lot designated as Assessor's Map 44, Block 31, Lot 6, along Post Office Square to the property served and designated as Assessor's Map 44, Block 31, Lot 3, known as 1 West Main Street has been in place for over 50 years, since at least 1963 when the existing system was installed, and the Selectmen have no objection to its continued use. The motion was unanimously approved.
