 A motion was made by MJ. Phelps, seconded by L. Gazzillo to approve the minutes of April 25, 2018 as submitted. The motion carried with a vote of 4 in favor and 2 abstentions (A. Kuever and M. Knudsen).

#### **Review Town Charter Recommendations:**

- A motion was made by M. Knudsen, seconded by L. Gazzillo to rescind the motion made on April 4, 2018 on Section 8-7 Fire Marshal; Deputies and leave section as written in the current charter (add "to serve a four (4) year term." and "for the same term."). The motion carried unanimously.
- The commissioners are waiting to hear from Attorney Bennet regarding some questions brought up at the last meeting.

- Change First Selectman to Chairman of the Council
- First line should read "All Town Meetings shall be called to order by the Chairman of the Town Council or the Vice Chairman of the Town Council."

#### Section 4-3 – Annual Town Meeting:

• Change Selectmen to Town Council

# Section 4-4 – Annual Budget Meeting:

• Change Board of Selectmen to Town Council

#### Section 4-4B - Annual Budget Meeting:

• Should read "Should either budget section fail to be approved by a majority of those voting thereon, the Town Manager and/or the Board of Education shall forthwith revise estimated expenditures, without altering estimates of revenue except for omissions, clerical errors, or revisions of revenue to be received from the state, to arrive at revised spending levels and automatically submit the revised budget section(s) to referendum 14 days following the date the initial budget referendum was defeated. The Town Council will review the revised budget and shall hold at least one (1) public hearing......"

- Change Board of Selectmen to Town Council
- Section should read "Special Town Meetings shall be required for approval by vote after recommendation by the Town Council."
