A motion was made by D. Traynor, seconded by J. Scully Welch to approve the minutes of April 16, 2018, May 9, 2018, May 14, 2018 and May 16, 2018 as submitted. The motion carried as follows:

- A motion was made by D. Onofrio, seconded by J. Scully Welch to approve the lease/purchase for the Hook Lift Truck for the Department of Public Works in the amount of \$215,538.44. The motion carried unanimously.
- The specifications included in the bid were explained
- The truck should last 25 years
- Trading in a 23-year-old vehicle
- Warranty is for 5 years

Finance Director's Report and Line Item Transfer Requests:

Appointment of Auditor Notification to reaffirm RSM:

- A motion was made by D. Traynor, seconded by O. Nejd to approve continuing with RSM as the Town's Auditor. The motion carried unanimously.

Line Item Transfers:

Police Department:

- A motion was made by D. Onofrio, seconded by J. Scully Welch to approve the Police Department line item transfer to increase account 014201-54311 (vehicle maintenance) by \$3,200 and reduce account 014201-54301 (service contracts) by \$3,200. The motion carried unanimously.

Department of Public Works:

- A motion was made by D. Traynor, seconded by J. Scully Welch to approve the Department of Public Works line item transfer to increase account 014301-51334 (OT snow ice) by \$853.75 and reduce account 014301-54301 (Sand Salt Materials) by \$853.75. The motion carried unanimously.

Department of Public Works:

- A motion was made by D. Traynor, seconded by D. Onofrio to approve the Department of Public Works line item transfer to increase account 014193-54300 (Repairs and Maintenance – to repair the Green Room doors at Town Hall) by \$5,000 and reduce account 014193-51320 (P/T Employees) by \$2,500 and reduce account 014193-51330 (OT) by \$2,500. The motion carried unanimously.

A motion was made by L. Santos, seconded by D. Onofrio to recognize First Selectman C. Goupil. The motion carried with a vote of 5 in favor and 1 opposed (D. Traynor).

A motion was made L. Santos, seconded by D. Onofrio to direct all questions through the chairman. The motion failed with a vote of 3 in favor (L. Santos, D. Onofrio, J. Olsen) and 3 opposed (D. Traynor, O. Nejd, J. Scully Welch). The motion failed.

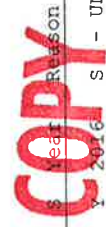
