# BOARD OF SELECTMEN TOWN HALL ROSE ROOM MAY 23, 2018 MINUTES

Everyone stood and pledged allegiance to the flag. The meeting was called to order at 7:00 PM.

### **VISITORS**

No visitors wished to speak at this time.

#### **APPROVAL OF MINUTES – MAY 16, 2018**

Walter made a motion, seconded by Scherban to approve the minutes from May 16, 2018. The motion was unanimously approved.

## **RESIGNATIONS/APPOINTMENTS**

Goupil informed the board that Zoning Enforcement Officer Eric Knapp has tendered his resignation. He has accepted a position in Westbrook.

### SECOND AMENDMENT TO LICENSE AGREEMENT WITH CROWN CASTLE

The board asked for the cost associated with the agreement. Walter made a motion, seconded by Sengle to table. The motion was unanimously approved.

#### **UNDERGROUND STORAGE TANK REMOVAL**

The town received a total of 13 bid responses. The bids were reviewed by the town's engineering consultant DTC. The two low bids were from Standard Demolition for \$88,800 and CTR for \$88,870. Although Standard Demolition is the low bidder a comparison of the supplemental bid pricing identified CTR as the low bidder should contaminated soils at any of the sites be discovered. The Town Hall and Station 2 were recently discovered and not included in the bonding package. The cost to remove the tank at the Town Hall was included in the bid package. The additional cost to include the Town Hall is \$16,400. The furnace at Station 2 needs to be replaced before the tank can be removed. Scherban made a motion, seconded by Walter to award the bid to CTR for \$88,870 which includes the removal of the underground storage tank at Town Hall. The motion was unanimously approved.

#### **EXECUTIVE SESSION – PERSONNEL AND CONTRACTS**

Walter made a motion, seconded by Scherban to go into executive session at 7:19 pm and invite Dawn Norton and Mary Schettino. The motion was unanimously approved. The board came out of executive session at 7:30 PM.

Scherban made a motion, seconded by Guerra to approve the Police Contract as presented. The motion was unanimously approved.

Scherban made a motion, seconded by Walter to hire David Melillo as the Human Services Director with a starting salary of \$79,000. The motion was unanimously approved. The Supervisors Union Contract states that new hired employees can be hired with a starting salary ranging up or down by 20 percent.
