## Zoning Enforcement Officer Report

### **Legal Actions:**

66 River Road: The court issued an injunction again Mr. Cashman ordering him to completely remove all non-permitted structures and uses. It also ordered monetary penalties of \$20,860, with additional penalty of \$150/day for each day beyond September 15, 2015 if the injunction is violated. Mr. Cashman has filed his appeal with the Appellate Court, and has now filed his appellate brief. Our appellate brief has now been filed. Oral arguments will be scheduled for Fall. On June 16, 2017, the bank moved to reopen the foreclosure action and requested a new sales date. It has subsequently submitted a new appraisal, foreclosure worksheet, military affidavit, affidavit of debt and affidavit re: attorney's fees. While no new sales date has yet been posted, it may be that the bank will complete its foreclosure prior to the appellate case being heard. At that point, Mr. Cashman would lose standing to continue his appeal, and presumably the bank would terminate any remaining violations.
