Town Manager's Corner

TIME OF RESILIENCY

I want to thank all Clinton residents who have made safe practices part of the new normal as a result of the coronavirus pandemic. Elbow bumps have replaced handshakes and masks are part of our daily attire. Virtually every aspect of our lives have been affected by this challenge. However, it has also been a time of resiliency and shown the strength of the Clinton Community.

The efforts of all of our professional first responders deserve recognition as they continue to meet the emergency needs of the community at a time of heightened risk. Many in the business community should also be thanked for their small acts of kindness that make our community. Cedar Island Marina and Kenyon donated masks to local first responders and others making it easier for them to do their job to protecting us all. Local manufacturers like Bausch Advanced Technologies, partnering with SCA Pharma, compounded more than 2,500 bags of alcohol based hand sanitizer now being donated at no cost to first responders and front-line healthcare workers in Connecticut fighting COVID-19.

We have all had to make changes – which may have tested our normal patience. We are not alone in having to make regular changes.

Town meetings have moved to a virtual platform which allows for public participation and for important business to be conducted. Meetings can be joined online or by phone. Each meeting agenda includes instructions for the public to participate. Recordings of the meetings are also available on the Town's website.

The Governor took action which prevented the annual budget referendum from happening this year. However, the Town Council still had its public hearing on May 6 and took additional steps to increase transparency in the budget process for the benefit of the public.

Additionally, recognizing that many residents are experiencing financial hardships now and the economic uncertainty that has come with the pandemic, the Town Council unanimously approved a low interest program for local taxpayers to provide some relief to those that will be challenged to pay their local property taxes on time.

From the Town Clerk's Office

June is the month to license your dog(s). Dogs licensed on or after July 1st will be charged a late fee of \$1.00 per month, per dog. Please stop in our office anytime to register or mail to the Town Clerk's office. Don't forget to include your rabies and spay/neuter certificate if applicable.

November 3, 2020 Presidential Election

Absentee Ballot applications are available in the Town Clerk's office and on the Town Clerk's website, click on Elections. AB ballots become available October 2, 2020.

Permanent Absentee Ballots: An elector can file an AB application together with a doctor's certificate (presumably on letter head), stating that they have a permanent disability and are unable to appear in person at their polling place. This will allow an elector to be on our Permanent Absentee ballot list. AB ballots will then be automatically mailed to the elector for the Presidential Election.

From the Tax Collector

REMINDER that June is the month to license your dog(s). We will need the RABIES CERTIFICATE and doctor's notice of SPAY/NEUTER if applicable. The fee during the month of June is \$8.00 if the dog is ALTERED and \$19.00 if not. Beginning July 1st a late fee of \$1.00 per dog, per month will be charged. Please call 860-669-9101 if you have any questions.

Also, November 3, 2020 elections are coming up. If you plan to be away at that time, you can apply for an absentee ballot beginning in August at the Town Clerk's office or by downloading the application from the Secretary of the State website, www.sots.gov. Click on Elections & Voting. Send application to Town Clerk, 54 E. Main St., Clinton, CT 06413. If you should have any questions call the Town Clerk's office or email townclerk@clintonct.org. Absentee Ballots will become available October 2, 2015.

PERMANET ABSENTEE BALLOT FOR DISABLED
Public Act #11-173: A disabled elector can file an Absentee Ballot Application together with a doctor's certificate stating that they have a permanent disability and are unable to appear in person at their polling place to obtain Permanent Absentee Ballot status. The law does not prescribe an official form

to be used so a note from the elector's doctor, presumably on letterhead, indicating the disability would satisfy this requirement.


Once the Application and doctor's certificate are received by the Town Clerk a copy will be provided to the Registrars of Voters to record on the Voter Registration Systems. Absentee Ballots will then be automatically mailed to the elector from the Town Clerk's office for eligible elections that allow for an Absentee Ballot to be mailed.

The Town Clerk will send an annual written notice in January of each year to determine if the elector continues to reside at the address on their Permanent Absentee Ballot Application. If there is no response from the elector, the elector will be removed from the status.

The Probate Court and You

A little known, and rarely used function of the Probate Court surfaced with this spring's daffodils at precisely the same time the COVID-19 pandemic blossomed in Connecticut – the court's jurisdiction over appeals of quarantine and isolation orders.

This facet of the court's authority is rarely seen because it typically comes into play in very specific and infrequent circumstances. Nevertheless, during a public health emergency, the Commissioner of Public Health may issue an order of isolation or quarantine to a person who: 1) is reasonably believed to be infected or exposed to a communicable disease such as COVID-19; 2) poses a significant threat to public health; and the Commissioner believes that quarantine or isolation is the least restrictive alternative to protecting and preserving public health. When Governor Lamont declared a public health emergency on March 10, 2020, he authorized and directed the Commissioner of Public Health to delegate its powers to order isolation or quarantine to local and regional public health directors, as its agent.

Quarantine refers to the physical separation or confinement of a person who has been exposed to a communicable disease, such as COVID-19, in order to prevent transmission to the general public.

Isolation refers to the physical separation or confinement of a person who is infected with a communicable disease in order to prevent or limit the transmission of the

disease to the general public. As Connecticut residents realized that COVID-19 infection could have severe consequences, including death, many residents voluntarily went into quarantine or isolation when they became aware of their own personal exposure to COVID-19, experienced symptoms of COVID-19, or received a positive COVID-19 test result, without the need for orders from local health directors.

During a public health emergency, individuals who receive orders of isolation or quarantine, and believe them to be inappropriate, have the ability to appeal the order to the Probate Court for the district where the individual is isolated or quarantined. The Probate Court holds a hearing within 3 days of receipt of the appeal. The request for the hearing does not automatically stay

the quarantine or isolation order. Because of the inability to practice proper social distancing during an appeal hearing, each Probate Court has secure video conferencing capability to allow the individual subject to the isolation/quarantine order to participate in the hearing.

To be able to respond to isolation and quarantine appeals, as well as to meet the critical needs of the vulnerable individuals we serve, the Saybrook District Probate Court remains open for normal business hours (Monday through Friday 8:30-4:30), with reduced staffing in order to comply with social distancing guidelines. Thank you to the dedicated court staff,

and especially Chief Clerk, Sharon Tiezzi, for an exceptional job in rising to meet our community needs during a very challenging time.

The Saybrook District Probate Court serves the nine towns of Chester, Clinton, Deep River, Essex, Haddam, Killingworth, Lyme, Old Saybrook and Westbrook.

with the Meeting ID and Password for the Meeting, and, if needed, step by step directions for accessing and using the software. Using the "Share Screen" feature, participants can see the art works as they are presented for review. Guest artists discuss that week's works providing insights into specific aspects of composition, color, and design. These remarks are followed by participant discussion. All paintings submitted to CAS by Wednesday at 5pm are reviewed at that week's critique.

Beginning Thursday, May 28, CAS will begin its bi-monthly Virtually LIVE Demonstration Series with acclaimed artist Frank Bruckmann. They have helped augment specific requests from community members. While periodic donations of large quantities of bikes do happen,

Egan relies on the generosity of community members to donate their unwanted bikes rather than throw them out. “Whether I strip them for parts or refurbish them to give away, every bike donation is important,” said Egan. “I have been so busy now, I often work on bikes that have been donated and given them away in the same day.”

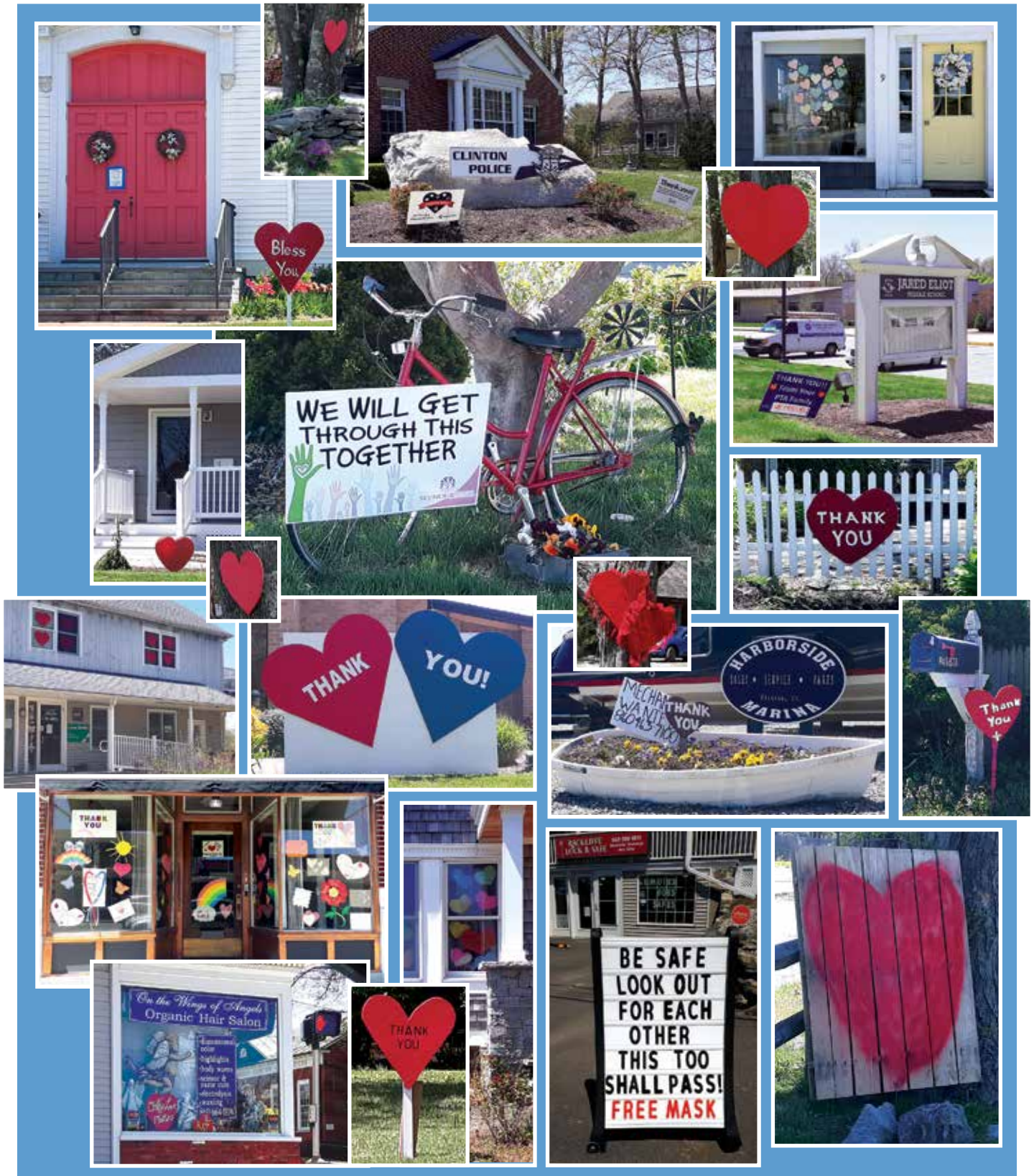
