MINUTES

Present: First Selectman Christine Goupil, Selectmen Jack Scherban, Tim Guerra, Carol Walter and Phillip Sengle

Everyone stood for the pledge of allegiance. The meeting was called to order at 8:00 AM.

Sengle made a motion, seconded by Scherban to add agenda item #2A – CME Contract Proposal for Interim Zoning/Wetlands Enforcement Officer. The motion was unanimously approved.

CME CONTRACT PROPOSAL FOR INTERIM ZONING/WETLANDS ENFORCEMENT OFFICER

Mary Ellen Dahlgren, Planning & Zoning Chairman and Chris Aniskovich, member of Planning & Zoning, reviewed the CME Proposal for Services. Planning & Zoning approved the proposal at their meeting earlier this week. Scherban made a motion, seconded by Guerra to approve the CME Proposal for an Interim Zoning/Wetlands Enforcement Officer and allow the First Selectman to sign the contract for \$4,000 per month not to exceed \$12,000 per quarter. The motion was unanimously approved.

APPROVAL OF MINUTES – MARCH 27, 2019

Walter made a motion, seconded by Scherban to approve the minutes from March 27, 2019. The motion was unanimously approved.

RESIGNATIONS AND APPOINTMENTS

Walter made a motion, seconded by Guerra to appoint Chuck Hill (U) to the Public Works Commission full seat for a term until June 30, 2021. The motion was unanimously approved.
