MINUTES

Present: D. Onofrio, A. Maklari, K. Carr, J. Scully Welch, J. Adler, T. Hollinger, O. Nejdil and L. Santos

D. Onofrio called the public hearing to order at 7:00 PM in the Auditorium of the Town Hall.

The public hearing was opened to comments on the Town and Education budget. Speakers were asked to keep their comments to 3 minutes. The following remarks were made.

The board received 6 letters in support of the Senior Exercise Program, 2 letters in support of the library and 1 letter from CERC in support of the Town Planner Position. The board also received a letter from the Park and Recreation Commission. A copy of the letters will be attached to the minutes.

Erica Gelvin, Board of Education Chairman, discussed the education budget and reviewed some of the budget savings with the board. The board conducted a facilities study to look at all of the buildings. The study concluded with an \$800,000 savings for this year due to the closing of Pierson School. The Board of Education is also recommending reducing capital by \$155,050 for a total budget of \$398,971.

Karin Gosselink, Andrea Reu, Laura Colebank, Maria Moran and Charleen Best all spoke in favor of the education budget and asked for no further reductions.

Michael Hughes, 8 River Road, spoke against the education budget.

Mary Gilbert, 45 Pearl Street, discussed the Library budget and asked the board to restore the \$10,000 reduction that was made to the budget.

John Allen, spoke in support of the town planner position.

Joe Schettino, Park & Recreation chairman, asked the board for them to restore funding to the repairs & maintenance budget.

Bob Werner, 13 Leffingwell Street, spoke on doing more with less and partnering with local business leaders.

Bruce Farmer addressed both budgets and spoke against the town planner position.

Helena Erskine, Senior exercise instructor, provided the board with a little history on the class and spoke on the need for the program to continue.

Christina Acampora, Glenwood Road, asked for \$10,000 to be restored to the library budget.

Melissa Yetso, 92 Glenwood Road, spoke on the parking lot near the Eliot baseball fields. The town rents the parking lot every year.

Richard Santanillo asked for \$10,000 to be restored to the library budget.

Phil Sengle spoke in support of the town planner position and the police overtime budget.

Amy Hursh, Founders Village asked the board to help seniors.

Andrea Reu spoke in support of the town budget.

To the Members of the Clinton Board of Finance:

We are writing this letter asking you to reconsider the cuts you have made to our proposed budget for the fiscal year 2019-2020.

For the number resources and facilities in our care and charge, the number of people our department services and the value of those services to all the people of our town, our budget is quite prudential and economical. Moreover, our department combines both frugality and practicality when using the funds entrusted to us. We cannot recall a time when we have returned to your board to request additional funds. Our department accomplishes much with what we are given and encourages the community to do even more (saving tax dollars along the way).

The cuts you have proposed would not just be burdensome but would prevent us from maintaining and cleaning facilities at a minimal level as well as prevent us from doing the job we are mandated to do in serving the public and fulfilling our duty to the town. For instance, you have cut our general supplies budget by \$2500.00, leaving us with just \$1000.00. The beach passes alone cost \$600.00 to produce. We are left with only \$400.00 to run and supply an office and staff for an entire year!

Our repairs and maintenance budget is required to maintain the facilities in a safe and clean condition and is required beyond the infrastructure repairs or projects planned for the long term through DPW. As a result of the cuts made to our repair and maintenance budget this year, we are unable to treat the lily pads at Hesel's Pond. With this budget you are guaranteeing that they won't be treated for two years consecutively.

If field lights need repair or playground equipment fails, it is up to us to correct the problems immediately for safety sake. The alternative is a shutdown. DPW has never been required to respond and they are not prepared to do so.

Our general maintenance budget was cut by \$3000.00. You have left us with \$800.00 to cover supplies and general maintenance of the buildings not covered by other department (e.g. painting, small repairs, paint, brushes, batteries, locks, chains, etc.)
