

**ANNUAL BUDGET MEETING
MAY 3, 2023
MINUTES**

The Annual Budget meeting was called to order by Town Council Vice Chair, Carol Walter, at 7:02 PM.

The first order of business was to elect a Moderator for this Annual Budget Meeting. Carol Walter was nominated and hearing no other nominations, Carol Walter, was unanimously approved to be Moderator of the Annual Budget Meeting.

The Moderator asked the Clerk to read the Legal Notice.

A Motion was made by Dennis Donovan and seconded by Maribeth Breen to waive the reading of the legal notice as in the newspaper and noticed, Motion passed.

The Following resolutions were opened for discussion:

To consider and act upon the budget of the Town for the next ensuing fiscal year beginning July 1, 2023, as prepared and recommended by the Town Council. Also, to consider and act upon the following resolution:

RESOLVED: that this Annual Budget Meeting adjourn to referendum in accordance with Section 10-2-F of the Town Charter, said referendum to be held on Wednesday, May 10, 2023, from 6:00 AM to 8:00 PM, with voting to be done by ballot and held in the Green Room of the Andrews Memorial Town Hall, 54 East Main Street, Clinton, Connecticut.

A Motion made by Hank Teskey and seconded by Carrie Allen to approve Resolution, Motion passed.

RESOLVED: In favor of the proposed Town Government Budget of the Town of Clinton for the fiscal year July 1, 2023 to June 30, 2024 in the amount of \$23,376,078.

A Motion made by Dennis Donovan and seconded by Hank Teskey to approve Resolution, Motion passed

RESOLVED: In favor of the proposed Board of Education Budget of the Town of Clinton for the fiscal year July 1, 2023 to June 30, 2024 in the amount of \$38,772,877.

A Motion made by Hank Teskey and seconded by Carrie Allen to approve Resolution, Motion Passed.

The Moderator asked for any questions or comments. Hearing none, the Moderator asked for a Motion to approve the Annual Budget Meeting to adjourn to Referendum along with Resolutions to approve the Town Government Budget and the Resolution to approve the Board of Education Budget on Wednesday, May 10, 2023, with voting to be done by ballot and held in the Green Room of the Andrews Memorial Town Hall, 54 East Main Street, Clinton, Connecticut between the hours of 6:00 AM to 8:00 PM.
