## Application:

**DRB 21-10:** 237 East Main Street, Ladybugg Cleaning; Applicant/Agent: Cleonice Bugg/Nolan Bugg; Project: Change design of pre-existing sign approval at site. Looking to do image for UHaul.

The applicant presented a rendering of the Uhaul sign they wish to put on the side of the building at 237 East Main Street. The size of the sign was previously approved for the space. Alan Kravitz suggested that the applicant contact the Land Use Office to verify that the size of the sign is ok. This item was tabled.

**DRB 21-11:** 237 East Main Street, LadyBugg Cleaning; Applicant/Agent: Cleonice Bugg/Nolan Bugg; Project: Change design of pre-existing sign approval at site. Looking to add images for LadyBugg Cleaning LLC.

The applicant presented a rendering of the sign to be used for LadyBugg Cleaning. After a brief discussion regarding placement and size of the sign, John Allen **moved** to approve <u>DRB 21-11</u> <u>Change design of pre-existing sign approval at site to image for LadyBugg Cleaning with the addition of a phone number.</u> The motion was **seconded** by Dara Onofrio and with no further discussion the motion passed.

**DRB 21-12:** 50 Nod Road, Storage Building; Applicant/Agent: 50 Nod Holdings, LLC, Adrienne Browning/Christopher M. McKeon, Esq; Project: Construction of 6,800 square foot storage building.

Michael Ott shared drawings of the proposed building including the location/visual from the main road. He also explained that 50 Nod Holdings purchased the single family home at 52 Nod Road which is slated to be taken down to allow for the new storage unit. There will be two loading docks on the side of the unit which will not face Nod Road. The plan is to do some plantings between the

unit and the road. John Allen told the applicant that the Design Review Board cannot vote on this application without a site plan. It was decided that the application should first go to the Zoning Board of Appeals, then return to the Design Review Board with a site plan.
