Meeting With Sustainability CT Interns

Committee members greeted Megan and Sofia, who will be available to assist with tasks related to the town's certification process. For the next meeting they will review previously completed action items to ensure they are not set to expire and are eligible for new/rolling credit for the pending certification application.

Discussion of Public Presentation for Composting Awareness

The committee's original plan to host an informational session on home composting was deemed possibly too narrow, and might be more beneficial as a focus topic in a more broad discussion of sustainable practices to reduce home/everyday waste generation. A potential presenter for this session has agreed to conduct the session, assuming public interest. The committee agreed to attempt to hold this session during the town Summerfest at the end of August if space remains. C. Allen will follow up with the relevant parties and report back before the next meeting.

Follow-up on Survey for Equity

Hugh is absent for this meeting, and as this project is primarily under his development, this agenda item will be addressed at the next regular meeting.

Additional Discussion Items

T. Abbatello mentioned activities of the town poet laureate as a potential for expanding credit of the action item 4.2 Supporting Arts and Culture, and will find out about ongoing poetry programs being held and report back at the next regular meeting.

C Zamecnik forwarded the town's adopted charter on conservation practices, to be uploaded on credit for action items under the section 3 header. J. Teague will determine the appropriate categorization and update the submissions.

- -Nominated candidates to fill the vacancy on the committee. Additionally Carrie will check as to whether the committee can admit additional members beyond the specified seven.

- -Megan and Sofia will review previously completed action item eligibility for credit.
