RECREATIONAL

- Shellfish beds A&B reopened Friday 10/3/25, a month sooner than anticipated after months of being closed.
 - The commission posted the opening on “Positively Clinton” on Friday (10/3) for public awareness.
 - Licenses are now available for purchase for the remainder of 2025 in Town Clerk’s Office.
 - Notice will be added to the Town Hall Led Sign
- Patrolling Report: J. Vander Werff reported seeing no one clamping
- Permit has been obtained for transport of clams for stocking during 10/10-10/17/25.
- During a recent volunteer clean up at Clinton Beach, concern was raised again, that even after almost 2 months there was a lot of firework shells/paper litter in the parking lot, beach, grass and a ***large concern of contamination in the water.***
 - Suggestions were made to present the town an alternative for next year of using a Drone Lightshow Display. Benefits: Safer, cleaner, less noise factor, less litter and safer for our waters.
- J. Vander Werff gave an update regarding the Shellfish handout; maps are being finalized and will be presented at next November’s meeting.
- Shore Road needs further discussion, research regarding signage and parking

LEASING/COMMERCIAL

- Indian River needs to be invoiced for their current 4 year lease. A. Walker will provide an invoice to Indian River.
- Discussion on proposed lease areas in Hammock & Hammonasset river. Discuss to be continued to clarify mapped out areas which are options.
