**TOWN HALL FLAT ROOF REPAIR BID AWARD**

Todd Hajek, Director of Public Works, recommended awarding the bid to the low bidder Elite Roofing and Restoration. Guerra made a motion, seconded by Walter to accept the bid from Elite Roofing and Restoration in the amount of \$38,200 for the Town Hall Flat Roof Repair. The motion was unanimously approved.

**TOWN MANAGER REPORT**

Guerra provided an update to the board.

- The search committee met last night with the newly elected Town Council and agreed on moving forward with 5 candidates. The candidates will be contacted by SGR.
- On December 2<sup>nd</sup> & 3<sup>rd</sup> the 5 finalists will be in town to be interviewed by the Search Committee, Town Officials and the Town Council. The public will have a chance to meet the finalists. The finalists are scheduled to fly in on Sunday, December 1<sup>st</sup> for Christmas in Clinton.
