This office has completed our review of the submitted plans entitled, "Sidewalk Improvements – East Main Street – Clinton, Connecticut" dated February 8, 2023. A final determination has been made and we find the proposal acceptable with one further comment at this time.

If the Town of Clinton chooses to submit the permit application in their name, then the bond requirement and application fee will be waived. Applications received from parties other than the Town of Clinton for this project will need to adhere to all the requirements listed below.

As regulated by Connecticut General Statute 13b-17, no work is to commence within the State right of way without first obtaining a DOT encroachment permit. In order to obtain the required encroachment permit, the following documents must be provided:

- Two complete sets of the latest town-approved plans (40 scale or larger).
- A completed encroachment permit application (State Form PMT-1 Rev. 5/91).
- A Bond on State Form CLA-5 in the amount of \$300,000 in the owner or developer's name.
- Proof of minimum insurance requirements (General Liability of \$1,000,000 and Aggregate of \$2,000,000). Insurance may be carried by the contractor.
- A check or money order in the amount of \$170 payable to "Treasurer – State of Connecticut."

These forms, along with additional information, may be obtained at www.ct.gov/dot.

This approval is valid for 3 years from the issue date of this letter.
